Term & Conditions:

1. Visa will take 5 - 7 working days for approval.
2. Visa approval purely depends on the immigration policies and procedures, (submission of the document doesn't mean visa approval).
3. Visa's validity is with respect to date mentioned on visa copy. Passenger is responsible to arrive on time and leave the country within the defined period of time.
4. Passport expiry date must be 6 months greater than visa application date.
5. Clear scanned passport copies required. [JPEG Format \ PDF]
6. Copy Itinerary (must be return ticket) and Hotel Booking [JPEG Format \ PDF]. In case of any changes to the flight marhaba staff should be notified 24 hours prior to the flight landing time by email:
7. In case of **visit visa**:
 - a. The passenger is not eligible to work during his visit with any company
 - b. Copy of smartcard and prove of address for the contact person in Bahrain. [JPEG Format \ PDF]
 - c. RP copy and Employment Certificate is required for the candidate and contact person in Bahrain.
8. In case of **business visa**:
 - a. This visa cannot be applied for non-business visit purpose
 - b. Guarantee letter should be attached with the application printed on the company letter head and signed by the authorized signatory.
 - c. Valid CR copy should be submitted with application
9. Bahrain Immigration rules are subject to change.

Refund Policy:

1. For business visa: once the application is processed than the amount is non-refundable either if it is rejected by the immigration or request for cancelation from applicant.
2. For 7 days or 14 days visit visa: in case of rejection from the immigration the service charges USD 107 will be applied and remaining will be refunded, and in case of requested for cancelation after application is been submitted the amount will be non-refundable.
3. For 30 days visit visa: in case of rejected by the immigration the service charges USD 80 will be applied, and in case of requested for cancelation after application is been submitted the amount will be non-refundable.
